

1. OBJECTIVE

This INTERNAL PRIVACY POLICY ["POLICY"] aims to demonstrate the commitment of Porto Central Complexo Industrial Portuário S.A. ["PORTO CENTRAL'] to the privacy and protection of the PORTO CENTRAL's Supplier(s) and Business Partner(s) Personal Data, covering the data collection, use, sharing, storage, reuse and disposal ["Data Processing"], whether physical or digital, in order to bring transparency about how and for what purposes your data is processed, in terms of Law No. 13,709/18 ["LGPD"].

2. APPLICATION OF THE POLICY

To ensure that Personal Data is secure, we actively communicate our privacy and security guidelines: (i) to PORTO CENTRAL Members, (ii) to PORTO CENTRAL's Legal Representatives and (ii) to PORTO CENTRAL's Supplier company(ies) and Business Partner(s).

Furthermore, PORTO CENTRAL requires those listed above to act actively in the application of this POLICY, strictly imposing safeguards on the privacy of your data.

3. DEFINITIONS

Suppliers(s)	Provider(s) of Goods and/or Services to PORTO CENTRAL.
Business Partner(s)	Companies and/or Institutions with which PORTO CENTRAL has understandings, commercial or economic commitments related to the exploration of PORTO CENTRAL's core activity.

INTERNAL PRIVACY POLICY

BUSINESS PARTNER(S) AND SUPPLIER(S)

Third Parties	Means contractors, who are not PORTO CENTRAL's Members and/or Officers, but present themselves or act on behalf of PORTO CENTRAL, including, but not limited to, suppliers, service providers, consultants, partners and any other natural or legal persons.
Personal Data	Any information related directly or indirectly to a person and that can be used to identify or contact that person (information of a physical, psychological, mental, economic, cultural or social nature).
Non-Personal Data	Data that, analyzed independently, does not allow direct association with a person.
Anonymization	The process by which Personal Data relating to a person becomes non-identifiable, considering the use of reasonable technical means available at the time of processing.
Confidentiality	Ownership of Data, in which it is not available or disclosed to unauthorized individuals, entities or processes.
Consent Form for Data Processing	Authorization to use Personal Data, under the terms of this POLICY.
Information processing	Appropriate use of data under the terms of the LGPD, following the guidelines established in the various scenarios that occur on a daily basis (storage, transmission, disposal, printing, etc.).

4. GUIDELINES

4.1. Collection of Personal Data

The sharing and use of Personal Data will only be permitted as indicated in this POLICY.

The Personal Data collected may also be analyzed together with other information to which PORTO CENTRAL has access, in order to ensure compliance with the company's

legal and regulatory obligations and the provision and improvement of services and content, always respecting the provisions of this POLICY.

4.1.1. Examples of Personal Data that may be collected and stored:

- When utilizing our services (such as contacting us via the website or in person), a small registration will be conducted, including Personal Data from the company's legal representative.
- When you share content with family and friends using PORTO CENTRAL services, the data provided about these individuals may be collected.
- While browsing our websites, we may collect data that allows us to identify your device (static IP/MAC address, persistent cookies), as well as other clickable data (activity history, security-related questions and answers, etc.).
- Upon signing the service provision contract, goods and merchandise purchase contracts, or contracts related to Business Partnerships, certain Personal Data will be collected from the company's legal representative for signature.
- Storage of Personal Data resulting from the contracting of services for the execution of socio-economic activities subject to PORTO CENTRAL's environmental programs established by IBAMA, within the scope of its environmental licensing.

4.2 Use of Personal Data

Personal Data collected through our communication channels (whether via the website, by telephone, in person, or any other means) enables us to keep users updated on the latest services, project progress, and events hosted by PORTO CENTRAL. Users may request, at any time, to stop receiving information sent by PORTO CENTRAL by emailing privacidade@portocentral.com.br.

Personal Data is also used to create, develop, operate, provide and improve our products, services, content and advertising, as well as to prevent losses and fraud.

We may use Personal Data to send important notices, such as communications about the services and changes to our terms, conditions and procedures.

We may also use Personal Data for internal purposes, such as auditing, data analysis and research aimed at improving products, services and communication with PORTO CENTRAL Business Partner(s) and Supplier(s).

4.2.1. Examples of Use of Personal Data:

PORTO CENTRAL may use the information collected to:

- Respond to any queries and requests;
- Comply with court order;
- Comply with legislation;
- Comply with legal or regulatory obligations;
- Establish, defend or regularly exercise rights in a judicial or administrative context;
- Ensure the safety of Business Partner(s) and Supplier(s);
- Keep records updated for contact purposes via landline, cell phone, email, SMS, direct mail, social networks or other means of communication;
- Promote products and services and inform about new opportunities and benefits;
- Generate information that assists in the study of implementing new methodologies in PORTO CENTRAL;
- Improve the functioning of the website, products and services as well as other tools and platforms launched by PORTO CENTRAL and its Third Parties.

The data obtained may only be accessed by professionals duly authorized by PORTO CENTRAL, respecting the needs to which they will be submitted, the relevance to the objectives of the website and the interests of the Business Partner(s) and Supplier(s).

4.2. Cookies and other technologies

When visiting our websites, using our online services or using any of our applications or tools, it may be necessary to use "cookies" or other technologies, such as pixel tags and web beacons. These technologies help us better understand the behavior of PORTO CENTRAL's Business Partner(s) and Supplier(s), inform us which parts of our website have been visited, helping to measure the effectiveness of advertisements and web searches. Information collected by cookies and other technologies is treated as Non-Personal Data. As Non-Personal Data is combined with Personal Data, the combined information is treated as Personal Data for the purposes of this POLICY.

PORTO CENTRAL and its Third Party(s) use cookies and other mobile advertising service technologies to control the number of views of a given advertisement, show advertisements according to the interests of the PORTO CENTRAL' Business Partner(s) and Supplier(s) and evaluate the performance of advertising campaigns. If PORTO CENTRAL's Business Partner(s) or Supplier(s) do not wish to receive advertisements with this level of relevance on their device, they may opt-out.

4.3. Sharing with Third Party(s)

PORTO CENTRAL may share Personal Data with Third Party(s) who provide specific services aimed at Business Partner(s) and Supplier(s), such as processing, managing and improving your data, providing customer service, assessing interest in our

4.4. Sharing of Personal Data

Legislation and/or public agents, local or international, may require PORTO CENTRAL to reveal your Personal Data. We may also disclose Personal Data if we determine that for purposes of national security, law enforcement or other public policy concerns, disclosure is necessary or appropriate.

We may also disclose Personal Data if we determine that disclosure is reasonably necessary to enforce our terms and conditions or protect our operations, or PORTO CENTRAL's Business Partner(s) or Supplier(s).

In the event of a reorganization, merger or sale, we may transfer any and all Personal Data we have collected to the Third Party(ies) involved.

4.4.1. Sharing of Personal Data between companies that make up the Organization that PORTO CENTRAL is part of

We commit to maintaining a consistent and adequate level of protection for Personal Data that is processed and/or transferred between the various legal entities belonging to the Organization to which PORTO CENTRAL is a part. A data transference to another legal entity within the same Organization is considered an internal data transference and, therefore, already covered by the authorization in the Consent Form.

4.4.2. Sharing of Personal Data with Third Party(s)

The information database formed by PORTO CENTRAL may be made available to Third Parties, who are strategic Business Partners for the benefit and generation of mutual results, such as the provision or improvement of our products, services, and advertising. Third parties may not use the PORTO CENTRAL database for their marketing actions.

In the case of sharing Information with Third Parties, PORTO CENTRAL must make sure that (i) the other legal entity has the structure to apply the rules, guarantees and restrictions existing in this POLICY for the transfer and subsequent use, processing and storage of Personal Data, (ii) the transference of Personal Data is in accordance with applicable Data Protection legislation and supported by contract, and (iii) the

processing of Personal Data is limited to the purpose for which the transfer agreed by the generating legal entity in PORTO CENTRAL.

4.5. Protection of Personal Data

PORTO CENTRAL's online services ensure the protection of your Personal Data during transmission through encryption. Furthermore, data will be stored in encrypted form shortly thereafter.

While we implement robust security measures, it's important to acknowledge that no security system is entirely foolproof. Therefore, PORTO CENTRAL cannot be held liable for any potential damages or losses arising from system failures, viruses, or unauthorized database access affecting our products, services, and website, except in cases where we have acted with intent or gross negligence.

When utilizing any PORTO CENTRAL product, service, application, message forum, chat room, or social networking service, any Personal Data shared by Business Partners or Suppliers may be visible to and accessed by other users. In such instances, you assume responsibility for the Personal Data you choose to disclose.

Please note that if you include your name, email, or other Personal Data in a post, this information becomes public and is solely your responsibility.

4.6. Integrity and Retention of Personal Data

PORTO CENTRAL allows its Business Partner(s) and Supplier(s) to easily keep their Personal Data accurate, complete and up to date. We will retain Personal Data for the period necessary to fulfill the purposes described in this POLICY, unless a longer retention period is required or permitted by law.

4.7. Access to Personal Data

PORTO CENTRAL's Business Partners and Suppliers play a vital role in ensuring that your contact information and preferences remain accurate, complete, and up-to-date.

You have the option to request updates, corrections, and deletions of any stored Personal Data unless PORTO CENTRAL is legally obligated or has legitimate commercial reasons to retain it.

We reserve the right to refuse processing requests that are unfounded, vexatious, infringe upon the privacy of others, violate applicable laws, are highly impractical, or are not otherwise mandated by law.

If a request for access, correction, or disposal is declined, PORTO CENTRAL will provide a written explanation for the decision to the requester.

4.8. Location Services

To provide location services related to its products and services, PORTO CENTRAL and/or its Third Party(ies) may collect, use, and share location data, including the geographic location of the device. This location data is collected anonymously so that it does not identify PORTO CENTRAL's Business Partner(s) or Supplier(s) personally and is used to provide and improve products and services.

Some location services offered by PORTO CENTRAL may require the inclusion of Personal Data.

4.9. Third-Party Sites and Services

PORTO CENTRAL websites, products, applications, and services may contain links to third-party websites, products and services. Our products and services may use or offer third-party (s) products or services, such as a third-party application(s) for iOS, Android and/or Windows Phone. Information collected by Third-Party(ies), which may include location data or contact information, is governed by the privacy practices of such third-party (ies), which we encourage to be known by PORTO CENTRAL's Business Partner(s) and Supplier(s).
